6. Renter must notify Castaways at Coon Creek, LLC of intent to sell camper/boat. Sold property must be removed immediately or a new contract created at time of sale. No prorated refunds.
7. Renter agrees to pay all expenses and costs incurred by Castaways at Coon Creek, LLC, including reasonable attorney fees, for any efforts necessary to collect rent due or the removal of abandoned property.
